Area of high- water stress	 The ratio of total annual water withdrawal to total available annual renewable water supply (i.e., baseline water stress) is high (40-80%) or extremely high (>80%);
	ii. The ratio of water consumption-to-availability (i.e., water depletion) is moderate (dry-year depletion, where for at least 10% of the time, the monthly depletion ratio is >75%), high (seasonal depletion, where for one month of the year on average, the depletion ratio is >75%), or very high (ongoing depletion, where the depletion ratio on average is >75%). Regions where the percentage of total water withdrawn is high (40-0%) or extremely high (greater than 80%) in the Aqueduct Water Risk Atlas tool of the World Resources Institute (WRI). See also water scarcity.

Best Available Techniques (BAT) conclusions	[DELETED] A document containing the parts of a BAT reference document laying down the conclusions on best available techniques, their description, information to assess their applicability, the emission levels associated with the best available techniques, the environmental performance levels associated with the best available techniques, the minimum content of an environmental management system including benchmarks associated with the best available techniques, associated monitoring, associated consumption levels and, where appropriate, relevant site remediation measures.
Best Available Technique Associated Emission level (BAT AEL)	[DELETED] The range of emission levels obtained under normal operating conditions using a best available technique or a combination of best available techniques, as described in BAT conclusions, expressed as an average over a given period of time, under specified reference conditions, i.e., the emission level that is associated with a BAT.
Best Available Technique Associated Environmental Performance Level (BAT AEPL)	[DELETED] The range of environmental performance levels, except emission levels, obtained under normal operating conditions using a BAT or a combination of BATs.
Best Available Techniques (BAT)	[DELETED] The most effective and advanced stage in the development of activities and their methods of operation which indicates the practical suitability of particular techniques for providing the basis for emission limit values and other permit conditions designed to prevent and, where that is not practicable, to reduce emissions and the impact on the environment as a whole: i. 'techniques' includes both the technology used and the way in which the installation is designed, built, maintained, operated and decommissioned; ii. 'available techniques' means those developed on a scale which allows implementation in the relevant industrial sector, under economically and technically viable conditions, taking into consideration the costs and advantages, whether or not the techniques are used or produced inside the Member State in question, as long as they are reasonably accessible to the operator; and iii. 'best' means most effective in achieving a high general level of protection of the environment as a whole.
